Performance Plus K9 Activity Center agrees to exercise due and reasonable care to keep our kennel premises sanitary and safe for your dog. There will be kennel staff on site 24 hours a day during your dog's stay. Our facility is equipped with a monitored fire protection sprinkler system.

Choose the stay option you want for your dog:

() SIMPLE STAY™ - Your dog will be fed properly and regularly. He will be cared for and housed in clean, safe quarters. He will be taken out to eliminate numerous times throughout the day. All his physical needs will be met.

() SUPER STAY™ - Your dog will be fed properly and regularly. He will be cared for and housed in clean, safe quarters. After breakfast he will move to the Day Room to participate in our Train-n-Play™ program where he will be properly socialized, exercised, and trained on daily life skills. At the end of the day he will return to his kennel exhausted and emotionally satisfied, ready to have dinner and settle in for the night reassured that everything is okay. All his physical and emotional needs will be met.

If a pet, which is presented for boarding, is found to have fleas and/or ticks, it will be treated at the owner's expense. (____) owner's initials

IMPORTANT: We do not accept bitches in heat or due to come into heat. While your dog is staying with us, if we determine that he or she requires special care and attention due to issues with behavior, temperament or estrus, there will be an upcharge of \$10-\$25 per night depending upon the severity of the problem. (____) owner's initials

It is required that you individually bag each of your dog's meals for the duration of his stay. There will be a \$5 per day charge if the food is not individually bagged. If your dog refuses to eat the food you provide, we will try everything in our power to encourage him to eat. That may include purchasing some specialty items, such as broth, premium canned food, hamburger and rice etc. as well as hand feeding him. There will be a \$2.50 per meal upcharge if that is the case. (____) owner's initials
